CENSUS 2010 | WHY IT MATTERS



The information collected through the census is the basis for distributing \$400 billion in federal funds. This money is used for things like building senior centers, hospitals, job training centers, schools and funding for public-works projects. It also determines the number of seats Pennsylvania has in the U.S. House of Representatives. Most importantly, census counts determines funding for organizations like ours...which will have a direct effect on our ability to serve you!

The 10 question form takes about 10 minutes to fill out. It contains basic questions asking your name, age, race and gender. Answers to the questions remain confidential and will only be used for the Census. The form is mailed to your home and even comes with a postage-paid envelope to return your responses free of charge. You cannot fill out a census form online.


The census is taken once every 10 years. Please take the time to complete your form. Without an accurate count, Pennsylvania will not get its fair share. After all, you have nothing to lose and everything to gain from it.

- 1) File for unemployment compensation: Go to www.dli.state.pa.us to begin an application or call toll-free at 1-888-255-4728.
- 2) File a wage complaint: Go to www.dli.state.pa.us to file an application on-line or to print out an application and mail it in.
- 3) File a charge for employment discrimination: Go to www.eeoc.gov for the Equal Employment Opportunity Commission, a federal agency, or www.phrc.state.pa.us for the Pennsylvania Human Relations Commission, a state agency.

EMPLOYMENT LAW AND YOU

Neighborhood Legal Services Association has had a long history of representing clients with unemployment compensation issues. However, limits on staff time and funding made it almost impossible to provide assistance in other areas of employment law. In the past decade, the need of low-income residents for representation in all areas has grown dramatically.

Due to this demand, NLSA and its partners began the Pennsylvania Employment Project in 2006. The project was developed to expand the area of legal representation and advice for clients who have more specific employment issues. Today, the areas NLSA deals with can be broken down into three main components:

1) Barriers to Employment

- expungement of arrest records
- pardon process
- expungement of unsubstantiated child abuse allegations
- driver's license suspensions
- non-compete agreements

2) Job Preservation

- family and medical leave
- employment discrimination
- workers rights

3) Preserving/Obtaining Income Benefits

- unemployment compensation
- wage claims
- pensions
- employer provided disability benefits
- child support garnishment
- at will discharges
- misclassification as an independent contractor

The biggest issue NLSA sees currently is criminal records preventing employment. There are many employers that are contracting with private companies to run criminal background checks on all applicants for jobs. The private companies are then not always using the best information or resource to research an individual's criminal record. This results in the private companies supplying possible employers with incorrect criminal record information that may prevent that individual from getting a job with that employer.

Our office works to help clients clean up criminal records and be informed as to what is appearing on their criminal records so they are

TIPS ABOUT **EMPLOYMENT**

- 1. Obtain your Pennsylvania State Police report (\$10 fee) to be sure what is appearing on your criminal record.
- 2. Be sure not to lie or misrepresent yourself on a job application - you can be fired for it and denied unemployment compensation benefits!
- 3. If you are having problems in the workplace, document everything. If there are disciplinary actions taken against you, ask for copies.
- 4. Keep track of the time that you worked and compare it against your pay stubs to be sure that you are being paid properly.

ready to explain it to the employer or correct any inaccurate information that a private company has supplied to the employer.

WHAT IS NLSA?

Neighborhood Legal Services Association (NLSA) is a private, nonprofit corporation created to provide high quality, free civil legal services to low-income individuals, the elderly and victims of domestic violence of Allegheny, Beaver, Butler and Lawrence counties.

NLSA represents clients in many ways depending upon the type of legal problem. The more serious problems will result in an NLSA attorney providing representation. Less serious matters will result in the client only getting advice and/or a referral to a private attorney who may provide the representation at a reduced rate. This is because we simply do not have enough attorneys to provide everyone with an attorney. We have to set priorities...sort of like emergency rooms which practice triage when the need outweighs the capacity of the organization.

We provide an attorney in Protection From Abuse cases; evictions from public/subsidized housing; some private housing evictions; tax sales of homes; mortgage foreclosure; wage claims; expungements; child custody where the child has been snatched or the custodial parent has been sued by the non-custodial parent for custody; SSI denials; unemployment compensation; public benefit denials (Medicaid/TANF/GA/Food Stamps); utility terminations; bankruptcy to protect a residence or stop a utility termination; and executions on essential personal property.

If you do not have one of these problems, you may get telephone advice and/or a reduced fee referral to a private attorney who will provide representation at a reduced rate. These cases include support; divorce; other custody/visitation matters; non-emergency bankruptcies; debt collection matters; and general landlord tenant matters involving security deposits or maintenance issues.

We also have a few special grants to help specific populations. Some of these include: the elderly (60+) at Senior Centers in Allegheny County, to counsel folks in danger of foreclosure, and to represent children in guardianship proceedings in Beaver County.

CASE IN POINT Actual Client Stories

Deborah TOPIC:

Unemployment & Public Benefits

Deborah was denied Supplemental Security Income (SSI) after a series of strokes left her unable to continue her career as a hair stylist. The denial was based on the court's expectation that her condition would improve enough for her to go back to work. Deborah attempted to return to her workplace in some capacity; however she was unable to stand or sit for any length of time and she could no longer read, write or even recall phone messages.

She tried unsuccessfully to appeal the SSI decision on her own, then turned to NLSA. While Deborah survived for 18 months on public assistance and help from friends and family, NLSA gathered medical evidence establishing her right to benefits designed for low-income people who cannot work due to disability. At the appeal hearing, the judge agreed that Deborah qualified for SSI and ordered benefits to be paid retroactively. That modest income enabled her to shift some of the financial responsibility from her family to herself.
