

Neighborhood Legal Services Association, as an Internal Revenue Code Section 501 (c) 3 charitable organization is eligible to receive tax deductible contributions. As such, contributions are deductible to the extent allowed by the Internal Revenue Service. Individuals wishing to support the mission of NLSA may do so by making gifts of cash (checks made payable to NLSA), or of securities (stocks, bonds, mutual funds), or by credit card. Giving

For the clients of NLSA, justice is not an abstract ideal. It is food, shelter and protection. Each year, NLSA helps more than 20,000 low-income individuals and their families meet their most basic needs and improve their lives.

Of necessity, virtually all of the clients for whom NLSA attorneys or volunteer lawyers from the private bar provide full representation have critical basic survival issues such as imminent loss of housing, income or personal safety. This leaves countless other situations that we can handle through our legal advice Helpline.

NLSA's biggest hurdle is keeping up with the overwhelming demand for services. Current funding for legal aid falls far short of the local demand for services. In a recent 2-month service audit, NLSA turned away 1689 requests for legal aid. Various legal needs studies undertaken over the past 15 years have consistently shown that the civil legal aid system can only provide representation to one in every five low-income individuals needing civil legal assistance. These studies consistently show that at least 80% of low-income people with critical civil legal problems do not receive legal help with these pressing needs. Given that one in every nine Pennsylvanians is living in poverty, and 199,432 individuals and their families are living in poverty in our 4 county service delivery area, it is imperative that NLSA's help continue to be available to them.

NLSA works diligently to raise additional monies to support programs and services for those who have nowhere else to turn for help. NLSA has a solid reputation for being a good steward of your gift with a low overhead efficiency ratio and is a well-managed nonprofit organization governed by an active and engaged 39-member Board of Directors. Every year, NLSA must raise monies through philanthropic donations to support programs and services for victims of domestic violence and low-income individuals and their families who have nowhere to turn.

Donations From Your IRA

The Pension Protection Act of 2006 allows for people aged 70 ½ to make a donation to a charity directly from their IRA. The distributions are tax-free and will avoid penalties for early withdrawl. Donors are allowed to donate up to \$100,000 per year through their 401k.

This may be of great benefit if you are:

- Age 70 ½ or older; and
- Are required to take a distribution from your IRA or
- Do not itemize deductions on your taxes or
- Charitable gifts already equal 50% of your adjusted gross income or
- Are subject to the 2% rule that reduces your itemized deductions.



Cy Pres

NLSA has received several cy pres and other court awards. These court awards can provide significant support for NLSA's work on behalf of victims of domestic violence and the low income community.

Cy pres, meaning "as near as possible," was originally used as a way of distributing an estate or trust fund whose primary purpose could not be fulfilled. The cy pres doctrine enabled these funds to be distributed to the "next best" use. Today, the Cy pres legal doctrine allows for the distribution of class action residual funds, estates or unclaimed trusts for a purpose as near as possible to the interests of the class or intended use of the estate or trust. The Pittsburgh Foundation's Match Day



After a weekend visit the father of Sandra's son refused to return the child and disappeared with him to another state. Sandra came to NLSA with the father's new address and frantic with concern after learning that the man had been accused of child molestation by a member his family. immediately filed a custody complaint in the Court of Common Pleas. Sandra traveled to the state and, with the courtordered assistance of the local sheriff, was able to retrieve her child. Upon Sandra's return, NLSA represented her at a conference where she custody granted full custody of her son and all visitation and custody rights of the father were stopped.
